C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Fourteen Thousand and no/100**

DOLLARS (\$ **14,000.00**.....), with interest thereon from date at the rate of **six & one-half** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, a short distance south of Little Texas Road and being shown as property of Allen J. Wright containing 3.8 acres, more or less, as will appear by reference to plat book 00 at page 367 and having, according thereto, the following metes and bounds, to-wit:

Beginning at an iron pin at or near the edge of the small service road which iron pin is situate 501 feet, more or less, S 43-45 E, from Little Texas Road and running thence with said road S 33-15 E, 355 feet to an iron pin; thence N 65-45 E, 420 feet to an iron pin; thence N 33-15 W, 407 feet to an iron pin along Marchbanks property; thence S 65-45 W, 400 feet to an iron pin in said road; thence S 34-55 E, 52 feet to an iron pin; thence crossing said road, S 66-45 W, 20 feet to the point of beginning.
