NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeasterly side of Fleetwood Drive, near the City of Greenville, S.C., being shown as Lot No. 38 on the plat of Magnolia Acres as recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Fleetwood Drive, located at a point 374.4 feet Northeast of the Easterly corner of the intersection of Fleetwood Drive and Cool Brook Drive, said pin being the joint front corner of Lots 37 and 38, and running thence along the joint line of said lots S. 25-49 E. 160 feet to an iron pin in the line of Lot No. 40; thence with the line of Lot No. 40 N. 40-28 E. 42.4 feet to an iron pin, common corner of Lots Nos. 38, 39 and 40; thence with the joint line of Lots 38 and 39 N. 7-38 E. 152.7 feet to an iron pin on the Southerly side of Fleetwood Drive; thence along the Southerly side of said Drive on a curve, the chord of which is S. 79-38 W. 57 feet to an iron pin on the Southeasterly side of said Drive; thence with the Southeasterly side of Fleetwood Drive S. 64-11 W. 68 feet to the point of beginning.
