All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 167, Section C, Woodfields, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book W, page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Pine Creek Drive, joint front corner Lots 167 and 168, said iron pin being 290 feet from street return at Hillside Lane; and running thence along Pine Creek Drive S. 56-32 E. 90 feet to an iron pin, joint front corner Lots 166 and 167; thence S. 33-28 W. 166 feet to an iron pin, joint rear corner Lots 166 and 167; thence N. 56-32 W. 46 feet to a point; thence N. 61-32 W. 44.1 feet to an iron pin, joint rear corner Lots 167 and 168; thence N. 33-28 E. 170.2 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
