SEND GREETING:

Whereas, we, the said Charlie J. Reeves and Willie Mae Reeves
in and by our certain promissory note in writing, of even date with these
Presents, we are well and truly indebted to Bank of Piedmont
in the full and just sum of (\$402.66) Four Hundred Two and 66/100

, to be paid Payable in eighteen monthly installments of
of \$22.37 each beginning January 17, 1960

, with interest thereon from maturity
at the rate of 6 per centum per annum, to be computed and paid in advance

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage

Greenville County" made by Dalton & Neves, February, 1950; Sections 3 and 4
of said plat are recorded in the R. M. C. Office of Greenville County in Plat Book Y,

and fronts thereon 100 feet.
