To all Whom These Presents May Concern:

NOW, KNOW ALL MEN, That I, the said J. W. Pitts

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Williams Land Company, Inc., its successors and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as lot #107 of a subdivision known as Thornwood Acres, property of Williams Land Co., Inc., according to plat by J. Mac Richardson, Engineer, dated April 1959, plat of which is recorded in the R. M. C. office for Greenville County, in Plat Book MM, at page 105, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of lots #107 and #106, and running thence along the line of these lots, N. 14-05 W. 193.1 feet to an iron pin in the line of lot #38; running thence N. 53-13 E. 31 feet to an iron pin; running thence N. 52-01 E. 50 feet to an iron pin at the joint rear corner of lots #107 and #108; running thence S. 25-24 E. 215.2 feet to an iron pin on the northern side of Merrywood Drive; running thence along the northern side of Merrywood Drive, which line is curved, the chord of which is S. 68-13 W. 56 feet to an iron pin; continuing along Merrywood Drive, S. 70-30 W. 29 feet to an iron pin, point of beginning; being the same conveyed to me by Williams Land Company, Inc. by deed of even date, to be recorded herewith.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors ~~Heirs~~ and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
