All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Pine Forest Drive in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 43, all of Lot No. 44, and a portion of Lot No. 45 of Block "B", Forest Hills Subdivision as shown on a plat thereof prepared by T.C. Adams, dated September 23, 1936, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book D at page 206, and having according to a more recent plat prepared by R.K.
