in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to US in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. G. Proffitt,

All that lot of land in the county of Greenville, state of South Carolina, being known and designated as Lot No. 27, and a small portion of Lot No. 26, on plat of Map No. 2 of Liberty Park made by Dalton & Neves, August 1958, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northwest side of Andrea Lane, the front joint corner of Lots Nos. 27 and 28, and running thence with the joint line of said lots N. 42-59 W. 152.4 feet to an iron pin in the rear line of Lot No. 24; thence with the rear line of Lots 24 and 25, S. 50-28 W. 95 feet to an iron pin in the joint rear line of lots 25 and 26; thence with a new line through lot No. 26, S. 39-35 E. 151.5 feet to an iron pin on the northwest side of Andrea Lane, the joint front corner of Lots Nos. 26 and 27; thence with the northwest side of Andrea Lane N. 50-46 E. 104 feet to the beginning corner.
