TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Ernest B. Kellogg and Helen H. Kellogg, Wife
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRYON FEDERAL SAVINGS AND LOAN ASSOCIATION OF TRYON, N. C. (hereinafter referred to as Mortgagee), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighteen Thousand Six Hundred Twelve and 94/100 DOLLARS (\$ 18,612.94), with interest thereon from date at the rate as specified in said note, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All those pieces, parcels or lots of land in Greenville and Spartanburg Counties, State of South Carolina, and being designated as tracts Numbers 7, 8, 12 and 13 of the T. J. Earle Estate, as shown on Plat made by W. N. Willis, July 3, 1919, and having the following metes and bounds to-wit:

Beginning on an old abandoned road on south Pacolet River, north-west corner of Tract No. 5 and running thence north 1 degree 43 minutes east 99 feet; thence north 12 degrees 14 minutes east 200 feet; thence north 26 degrees 09 minutes east 175 feet; thence north 26 degrees 39 minutes east 120 feet; thence north 1 degree 06 minutes east 225 to a stone, corner of tracts Numbers 7 and 13; thence with the line of tract No. 13 north 86 degrees 50 minutes west 1070 feet to a stone; thence north 67 degrees 40 minutes west 1043 feet to a stake; thence north 83 degrees 10 minutes west 682 feet to a stake; thence south 45 degrees west 1586 feet to a stake; thence north 37 degrees 10 minutes west 695 feet to a stake; thence north 26 degrees 50 minutes east 1380 feet to a stake; thence north 44 degrees east 874 feet to a stake; thence south 78 degrees 15 minutes east 1353 feet to a stake on Old Ballue Road; thence south 44 degrees 29 minutes east 240 feet to a stone; thence north 75 degrees 50 minutes east 1690 feet to a stone; thence south 30 degrees 15 minutes east 1426 feet to a stone; thence north 38 degrees 13 minutes east 458 feet to corner of tract No. 9; thence south 40 degrees east 126 feet; thence south 68 degrees east 200 feet; thence south 88 degrees 35 minutes east 815 feet; thence south 47 degrees 53 minutes east 127 feet; thence south 84 degrees east 232 feet; thence north 52 degrees 50 minutes east 203 feet; thence north 81 degrees 22 minutes east 425 feet; thence south 51 degrees 48 minutes east 100 feet; thence south 34 degrees 30 minutes east 156 feet; thence south 4 degrees 10 minutes west 1051 feet to corner of tract No. 6; thence with the line of tract No. 6 north 87 degrees 30 minutes west 1074 feet to South Pacolet River; thence up south Pacolet River at the line, to the beginning corner.

Tract No. 7 contains forty-eight and three-tenths (48.3) acres, more or less; Tract No. 8 (Mill Tract) contains forty-eight and three-tenths (48.3) acres, more or less; tract No. 11 contains fifty-four and four-tenths (54.4) acres, more or less; tract No. 12 contains eighty-eight (88) acres, more or less; and tract No. 13 contains twenty-eight (28) acres more or less, having a total of 267 acres more or less, Greenville County, State of South Carolina.
