WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Six Thousand and No/100** ----- DOLLARS (\$ 6000.00), with interest thereon from date at the rate of **six & one-fourth (6 1/4%)** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as a portion of Lot No. 1, Block "0" of the O. P. Mills property, as shown by plat recorded in Plat Book F, Page 226, R. M. C. office for Greenville County, and being more particularly described as follows:

BEGINNING at an iron pin on the west side of Grove Road which pin is 80 feet south from the southwest corner of Grove Road and Arthur Avenue; and running thence with Grove Road S. 18-37 W. 60 feet to an iron pin in line of Lot No. 2; thence with said lot N. 67-23 W. 173 feet to iron pin on Arthur Avenue; thence with said avenue N. 45-27 E. 58.1 feet to iron pin; thence S. 69-50 E. 146.5 feet to the beginning.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 345, Page 239.
