NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: near Greenville, S. C. on the northeastern side of Hillrose Avenue and being known and designated as Lot No. 16 of Green Vale, as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "GG", at Page 85 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Hillrose Avenue at the joint front corner of Lots Nos. 16 and 17 and running thence along said Avenue N. 45-35 W. 81 feet to an iron pin; thence along the joint line of Lots Nos. 15 and 16 N. 44-25 E. 171 feet to an iron pin; thence S. 26-36 E. 85.5 feet to an iron pin; thence along the joint line of Lots Nos. 16 and 17 S. 44-25 W. 143.2 feet to the point of beginning.
