

BEGINNING at an iron pin at the joint front corner Lots Nos. 26 and 25, and running thence along the joint line of said lots, N. 86-55 W. 158 feet to an iron pin; thence S. 3-10 W. 80 feet to an iron pin, the joint rear corner Lots Nos. 26 and 27; thence along the joint line of said lots, S. 86-55 E. 158 feet to an iron pin on the West side of Strawberry Drive; thence along the West side of Strawberry Drive, N. 3-10 E. 80 feet to an iron pin, point of beginning; being the same property conveyed to us by R. O. Nichols by his deed dated September 4, 1957 and recorded in the R.M. C. Office for Greenville County in Deed Volume 584 at Page 311.
