SEND GREETINGS:

WHEREAS, I/we the aforessid mortgagor (a) in and by my/elir certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eight Thousand Six Hundred and no/100 . . . (\$ 8,600.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 20 years after date. NOW KNOW ALL MEN, That I/we, the said mortgagor (c) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

Office for Greenville County, South Carolina, in Plat Book NN at Page 85, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin located on the Northeastern side of Miracle Drive, being the joint corner of Lots 144 and 145 and running thence N. 44-00 W. 124.7 feet along the northeastern side of Miracle Drive to an iron pin; thence following the curve of the eastern side of Miracle Drive, 21.9 feet, said curve having a chord running N. 4-39 W., to an iron pin located on the southeastern side of Miracle Drive; thence running N. 42-31 E. 100 feet along the Southeastern side of Miracle Drive to an iron pin, being the joint corner corner of Lots 145 and 146; thence running S. 48-00 E. 147.5 feet along the line of Lot 146 to an iron pin, being the joint rear corner of Lots 144, 145 and 146; thence running S. 46-00 W. 125 feet along the line of Lot 144 to an iron pin located on the Northeastern side of Miracle Drive, being the joint corner of Lots 144 and 145, the point of beginning; being the same property conveyed to me by J. P. Medlock by his deed of even date to be recorded herewith.
