TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ---Fifteen Thousand and No/100---

DOLLARS (\$ 15,000.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of West Prentiss Avenue, being shown and designated as all of lot # 5 of Block D on plat of property of O. P. Mills prepared by H. Olin Jones, Eng., in May 1914, which plat is recorded in Plat Book C at Page 176, RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of West Prentiss Avenue, at the joint front corner of lots # 4 and 5, and which pin is 89 feet N. 45-27 E. from the northeast intersection of West Prentiss Avenue and Elm Street; thence along the joint line of lots # 4 and 5, N. 44-33 W. 135 feet to an iron pin; thence along the rear line of lots # 2 and 3, N. 45-27 E. 89 feet to an iron pin in line of lot # 6; thence along line of lot # 6, S. 44-33 E. 135 feet to an iron pin on the north side of West Prentiss Avenue; thence with the north side of said Avenue as the line, S. 45-27 W. 89 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by Archer E. D. Booker and Mary Jane C. Booker by deed recorded in Book of Deeds \_\_\_ at Page \_\_\_.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
