TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Niles Ray Brown and

Edna B. Brown, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto LAURENS FEDERAL SAVINGS AND LOAN ASSOCIATION, LAURENS, S. C. (hereinafter referred to as Mortgagee), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, being lot # 54 on plat recorded in the R. M. C. Office for said County in Plat Book "BB" at page 51 and described as follows: BEGINNING at iron pin on North side of Florence Drive, corner of lot # 5 and running thence North 28-40 est 225 feet to iron pin, thence South 63-53 West 90.7 feet to iron pin, thence South 31-10 East 233.4 feet to iron pin on Florence Drive, thence along Florence Drive North 58-41 East 80 feet to the beginning.

The foregoing lot was conveyed to mortgagors by deed of A. O. Neves and Frank Neves, of even date herewith, to be recorded.
