NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Eastwood Court, in the City of Greenville, County of Greenville, State of South Carolina, and known and designated as Lot No. 11 of a Subdivision known as Eastwood Terrace, plat of which is recorded in the RMC Office for Greenville County in Plat Book MM, page 34, and according to said plat has the following notes and bounds, to-wit:

BEGINNING at an iron pin on the Southern Side of Eastwood Court, at the joint front corner of Lots Nos. 11 and 10, and running thence S 32-17 E 125.9 feet to an iron pin, running thence N 58-30 E 86.2 feet to an iron pin at the joint corner of Lots Nos. 11 and 12 and running thence N 32-17 W 127.5 feet to an iron pin on the Southern side of Eastwood Court, running thence along the Southern side of said court S 57-43 W 86.2 feet to an iron pin, point of BEGINNING.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
