TO ALL WHOM THESE PRESENTS MAY CONCERN: I, John W. Millwood, Sr.,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Thousand and Five Hundred -----

DOLLARS (\$ 15,500.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near the City limits of Greer, and being known and designated as Lots Nos. 34 and 35 on plat of BROOKWOOD Subdivision, prepared by B.B. Waters, Jr., Surveyor, October 14, 1958, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ, page 21, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Brookwood Drive, joint front corner of Lots Nos. 36 and 35, and running thence along the joint line of said lots, S. 87-27 E. 286.8 feet to a point; thence along the joint line of Lots Nos. 35 and 39, S. 87-27 E. 77.6 feet to an iron pin in the side line of Lot No. 40; thence along the side line of Lot No. 40, N. 2-44 E. 220 feet to an iron pin, joint rear corner of Lots Nos. 34 and 33; thence along the joint line of said lots N. 87-27 W. 366.1 feet to an iron pin on the east side of Brookwood Drive, joint front corner of Lots Nos. 33 and 34; thence along the east side of Brookwood Drive, S. 2-33 W. 220 feet to the point of beginning.
