with interest thereon from date at the rate of 7% per centum per annum, to be computed and paid Annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

E.H.Edwards and his heirs and assigns , forever, All that certain tract of land, with improvements thereon, located in said State and County, about one mile East of Batesville , and on the North side of Brushy Creek and on the west side of Augusta Road, and being a part of the same land conveyed to me by deed of R.W. Phillips and described as follows; Beginning a point in the center of bridge over Brushy Creek and the Augusta Road; thence with the center of said road as the line to a point where the road crosses the dividing line of the DeShields tract and the Payne tract ( two tracts formerly owner or now owned by R.W.Phillips; thence as the dividing line between said two tracts S. 64-30 W. 435 feet to a stone thence S/ 73-45 W. 1002 feet to a stone thence S. 81-15 W. 310 feet to a stone on Brushy Creek; thence down and with said creek as the line to the beginning and containing by estimation, thirty acres more or less.
