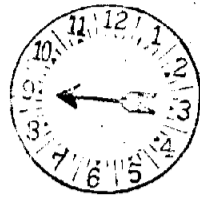

To All Whom These Presents May Concern: Mrs. Ollie Farnsworth R. M. C.

We, E. H. White, Jr. and Margaret J. White hereinafter called the Mortgagor^s, SEND GREETING:

WHEREAS, the said Mortgagors in and by their certain promissory note in writing, of even date with these Presents, are well and truly indebted to ~~MRS. OLLIE FARNSWORTH~~ GREER, S. C., hereinafter called Mortgagee, in the full and just sum of M. A. Mason Two hundred twenty-five and no/100 - - DOLLARS, to be paid as stated therein

with interest thereon from maturity at the rate of seven per centum per annum, to be computed and paid semi-annually in advance until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that certain lot of land in Greenville County, S.C. containing 1 acre more, or less. Being part of deed book 620 at page 265.

BEGINNING At old iron pin running thence N. 88W 432 1/10 ft. to point in new road, iron pin reference at S 88E 25 ft. thence with new road, N 4 E 151 ft. to nail in same, which is platted 36 wide on Campbell plat; thence S76-03 E. 374 5/10 ft. to point, thence S 37-30E 95 ft. to the beginning.
