All ~~that~~ certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the western side of the New Buncombe Road, near the City of Greenville, being shown as lots # 6 and 7, on a plat of the Perry Property recorded in the R.M.C. Office for Greenville County in Plat Book K at Page 144, and described as follows:

BEGINNING at a stake on the western side of New Buncombe Road, at corner of lot # 8, and running thence with line of said lot, S. 50-50 W. 200 feet to a stake; thence S. 39-10 E. 140 feet to a stake on line of lot # 5; thence with the line of said lot, N. 50-50 E. 200 feet to a stake on New Buncombe Road; thence with the Western side of said Road, N. 39-10 W. 140 feet to the beginning corner.
