"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side, of Finley Avenue in the City of Green, being all of Lots Nos. 21 and 22 and one-half of Lot No. 23 adjoining the same of the property of Nancy W.
