"BEGINNING at an iron pin on the eastern side of Yown Road, the joint front corner of Lots 83 and 84, and running thence along the joint line of said lots, S. 79-03 E. 175.5 feet to an iron pin, the joint corner of Lots 83, 84 and 85; running thence with the line of Lot No. 85, N. 85-15 E. 21 feet to an iron pin, the joint corner of Lots 82 and 83; running thence along the joint line of said lots, S. 23-15 W. 149.2 feet to an iron pin on the northern side of Autumn Drive at the joint front corner of Lots 82 and 83; thence running along the northern side of said Autumn Drive, N. 66-45 W. 139.8 feet to an iron pin in the intersection of said Autumn Drive and Yown Road; running thence with the curvature of said intersection, the chord of which is N. 29-15 W. 36.4 feet, to an iron pin on the eastern side of Yown Road; and running thence N. 8-15 E. 79.1 feet to the point of beginning; being the same conveyed to us by Myrtle Lord by her deed dated August 28, 1959 and recorded in the R.
