C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ----- Seven Thousand Three Hundred and no/100----- DOLLARS (\$ 7,300.00-----), with interest thereon from date at the rate of Six (6%) ---- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the Northwest side of Albion Circle, and being shown as Lot 5 on a plat of Berea Heights Addition, property of R. W. Jones, recorded in Plat Book S at page 102, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Albion Circle at the joint front corner of Lots 4 and 5, and running thence with the line of Lot 4, N. 39-10 W. 185 feet to an iron pin; thence with the rear line of Lot 2, S. 50-50 W. 100 feet to an iron pin, rear corner of Lot 6; thence with the line of Lot 6, S. 39-10 E. 186.2 feet to an iron pin on Albion Circle; thence with the Northwestern side of said Circle, N. 56-50 E. 99.8 feet to the point of beginning.

Being the same property conveyed to the mortgagor by R. W. Jones by deed recorded in Deed Book 559 at page 219.
