"BEGINNING at an iron pin on the northwestern side of Kay Drive at the joint front corner of Lots Nos. 97 and 98, and running thence along Kay Drive, N. 62-34 E. 90 feet to an iron pin; running thence with the curve of said Kay Drive, the chord of which is N. 30-19 E. 91 feet to an iron pin; running thence still with the curve of said Kay Drive, the chord of which is N. 34-33 W. 91 feet to an iron pin on the southwestern side of said Kay Drive; thence with the southwestern side of said Kay Drive, N. 67-00 W. 90 feet to an iron pin at the joint front corner of Lots Nos. 96 and 97; and running thence with the joint line of said lots, S. 23-00 W. 127.5 feet to an iron pin, the joint corner of Lots 96, 97 and 98; running thence with the joint line of Lots Nos. 97 and 98, S. 27-26 E. 127.7 feet to the point of beginning; being the same property conveyed to us by Don Reid and Ona Reid by their deed dated January 27, 1958 and recorded in the R. M. C. office for Greenville County in Deed Vol. 615, page 402."
