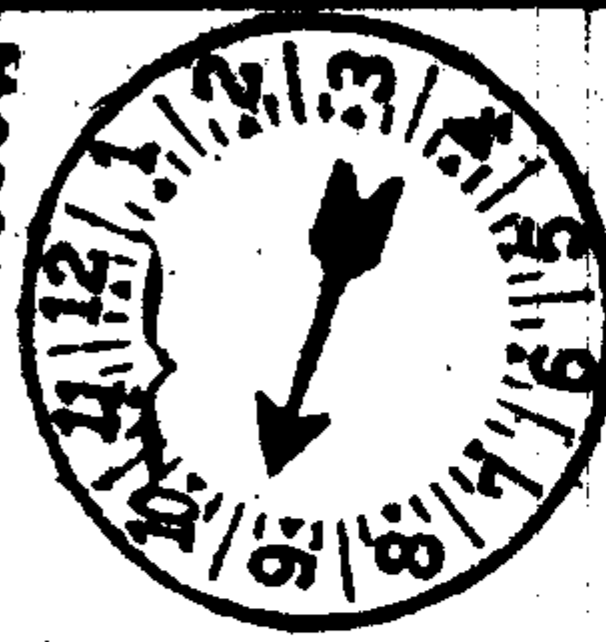

**To All Whom These Presents May Concern:**

SEND GREETING:

Whereas, we, the said Lewis Moore and Maedora Moore  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to Farmers Bank of Simpsonville  
in the full and just sum of Four Hundred Sixty and No/100 -- (460.00) Dollars  
, to be paid \$20.00 one month after date hereof and a  
like payment of \$20.00 on each succeeding month thereafter for  
a period of 22 months.

, with interest thereon from maturity  
at the rate of 7 per centum per annum, to be computed and paid in advance  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and  
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the
