This paragraph shall not however, in any way restrict advancements for taxes and insurance premiums provided for elsewhere in this mortgage. It is further mutually agreed that upon breach of any warranty against encumbrances contained in any application for an additional loan the mortgagee may declare all notes secured hereby immediately due and payable and may foreclose this mortgage. NOW, THEREFORE, the mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to him in hand paid by the mortgagee at and before the sealing and delivery of this mortgage, the receipt of which is hereby acknowledged, by these presents hereby bargains, sells, grants and releases unto the said SHENANDOAH LIFE INSURANCE COMPANY: All that certain piece, parcel or lot of land situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as Lot No. 46 of Western Hills as shown on Plat recorded in Plat Book QQ, at pages 98 and 99, R.M.C. Office for Greenville County, and being more particularly described according to Survey and Plat by R. B. Bruce dated April 5, 1960, as follows:

BEGINNING at an iron pin on the North side of Alice Farr Drive at the front corner of Lot No. 47; thence with the line of said lot, N. 8-21 W. 162.4 feet to an iron pin; thence N. 74-48 E. 138.5 feet to an iron pin in line of Lot No. 45; thence with the line of said lot, S. 7-13 W. 197.6 feet to an iron pin on said Drive; thence with said Drive, S. 88-39 W. 85 feet to the beginning.
