DOLLARS (\$ 3,000.00 ), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of ~~Pickens~~ Greenville,

said property lying and situate in Grove Township, containing 25/100 of an acre, more or less, having the following metes and bounds, to-wit: BEGINNING at an iron pin corner of Alvin Lollis property; thence along Moody Road in an easterly direction 70 feet to iron pin; thence in a northwestern direction 155 feet to iron pin, corner of John Allen Martin 70 feet to an iron pin joint corner of John Allen Martin and Alvin Lollis and grantor 70 feet to iron pin; thence in an eastern direction along line of Alvin Lollis 155 feet to BEGINNING corner."
