NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

BEGINNING at an iron pin on the Southern side of Forestwood Drive, the joint front corner of Lots Nos. 18 and 19 and running thence with the joint line of said lots, S. 12-0 E. 150 feet to an iron pin, the joint rear corner of Lots Nos. 18 and 19; thence with the rear line of Lot No. 19, S. 86-56 W. 123.7 feet to an iron pin, the joint rear corner of Lots Nos. 19 and 20; thence with the joint line of said lots, N. 5-23 E. 140.3 feet to an iron pin on the Southern side of Forestwood Drive, the joint front corner of Lots Nos. 19 and 20; thence with the Southern side of said Forestwood Drive, N. 82-28 E. 40.4 feet to an iron pin on the Southern side of said Forestwood Drive; thence continuing with the Southern side of said Forestwood Drive, N. 78-0 E. 39.6 feet to the point of beginning; being the same conveyed to us by W.
