

South 7 degrees 46 minutes East 65.4 feet to an iron pin; thence South 54 degrees 30 minutes West 179.5 feet to an iron pin on Scenic Drive; thence North 35 degrees 30 minutes West 50 feet to the point of the BEGINNING. This lot is also known as Lot # 30, Block C-3 Connecticut Heights as shown in revised plan of H. Stribling dated April 1, 1928.
