TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Luther L. Brown and Bessie W. Brown, (hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Twenty-five Hundred -----  
DOLLARS (\$ 2500.00 ), with interest thereon from date at the rate of Seven (7%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying at the intersection of Kay and Brown Streets in the City of Greer, being all of Lot No. 50 on a plat of property of the N.M. Cannon property, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book F, page 199, and having the following courses and distances, to-wit:

BEGINNING at a point on the east side of Kay Street (formerly Pine Street), at intersection with Brown Street, and runs thence with the eastern side of Kay Street, S. 13-00 E. 160 feet to an iron pin; thence N. 76-45 E. 61 feet along northern edge of Spring Street to an iron pin; thence along the common line of Lots Nos. 50 and 51, N. 13-00 W. 160 feet to an iron pin on the south side of Brown Street; thence S. 76-45 W. 61 feet to the beginning corner.
