WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Nine Thousand One Hundred and no/100 ... (\$ 9.100.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

BEGINNING at an iron pin on the northern side of Mapleton Drive, joint front corner Lots Nos. 184 and 185 and running thence along the joint line of said lots, N. 4-38 W. 160 feet to an iron pin on the line of Lot No. 181; thence along the line of that lot, S. 86-32 W. 110 feet to an iron pin on the eastern side of Greentree Road; thence along the eastern side of Greentree Road, S. 4-38 E. 135 feet to an iron pin; thence following the curvature of Greentree Road, as it intersects with Mapleton Drive, the chord of which is S. 49-03 E. 35.7 feet to an iron pin on the northern side of Mapleton Drive; thence along the northern side of Mapleton Drive, N. 86-32 E. 85 feet to the beginning corner; being a portion of the property conveyed to the mortgagor by R. C. Collins by his deed dated March 9, 1959 and recorded in the R. M. C. Office for Greenville County in Deed Volume 618 at Page 429.
