C., (hereinafter referred to as Mortgagor) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ----- Twenty-Five Thousand and No/100 -----

DOLLARS (\$ 25,000.00 ), with interest thereon from date at the rate of six (6%)

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate at the northwestern corner of the intersection of White Horse Road and Haviland Avenue, being shown and designated as Lots Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10 on plat of E. P. Kerns property, recorded in Plat Book W at Page 17, and when described as a whole has the following metes and bounds, to-wit:

White Horse Road and Haviland Avenue, and running thence with the north side of White Horse Road, N. 52-53 W. 200 feet to pin; thence N. 20-09 E. 440 feet to pin, rear corner of Lot 11; thence with line of Lot 11, S. 70-21 E. 187.3 feet to pin on Haviland Avenue; thence with the western side of Haviland Avenue, S. 19-39 W. 500 feet to the point of beginning; said premises being the same conveyed to the mortgagor by two separate deeds, recorded in Volume 424 at Page 154 and Volume 375 at Page 179.
