"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located about three miles northwest from Greer, on the west side of the Greer-Oneal Road (also known as the Gilreath Mill Road), and being Tract No. 2 on plat pf property of B.L. Smith Estate by H.S. Brockman, Surveyor, December 16, 1949, and being bounded on the north by Tract No. 1, on the east by the said road and lands now or formerly of E.R. Taylor, on the south by Tract No. 3 and on the west by lands formerly of Mell Bramlett, and having the following courses and distances, to-wit:
