

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his accont by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, in

the town of Mauldin and described as follows: BEGINNING at an iron pin 496.8 feet East of the C & WC Railroad and same distance from joint corner of property of Jim Willis Whitt and Mauldin High School property running thence North 24-06 West 301.5 feet to iron pin on unnamed street, thence along southern side of said street North 60-15 East 80 feet to iron pin to corner of property heretofore sold to Ben Adams, thence along line of Adams property South 24-06 East 301.5 feet to iron pin on line of Mauldin High School property, thence along line of Mauldin School property South 60-15 West 80 feet to the beginning.

The fore going land was conveyed to mortgagor by deed of Jim Willis Whitt, January 18, 1952, and recorded in the R. M. C. Office for said County in Deed Book 449 at page 409.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
