NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the Town of Mauldin in Austin Township, Greenville County, State of South Carolina, being known and designated as Lot No. 68 as shown on a plat prepared by R.K. Campbell, R.L.S., dated March 29, 1960, entitled "Windsor Park", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at page 25, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Swinton Drive at the joint front corner of Lots Nos. 68 and 69, and running thence with the line of Lot No. 69 N. 8-35 E. 205.5 feet to an iron pin in the rear line of Lot No. 95; thence with the rear line of Lot No. 95 N. 76-30 W. 32.8 feet to an iron pin at the joint corner of Lots Nos. 68, 95 and 97; thence with the rear line of Lot No. 97 S. 49-29 W. 102.8 feet to an iron pin at the joint corner of Lots Nos. 67, 68 and 97; thence with the line of Lot No. 67 S. 8-35 W. 130.6 feet to an iron pin on the Northern side of Swinton Drive; thence with the Northern side of Swinton Drive S. 81-25 E. 100 feet to the point of beginning.
