WHEREAS, the Mortgagor is well and truly indebted unto

are incorporated herein by reference, in the principal sum of THIRTEEN THOUSAND THREE HUNDRED & NO/100-

(5-3/4%) per annum until paid, said principal and interest being payable at the office of

or at such other place as the holder of the note may designate in writing, in monthly installments of  
SEVENTY-SEVEN and 67/100----- Dollars (\$ 77.67 ),  
commencing on the first day of July, 1960, and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of June, 19 90.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,  
situate, lying and being near the City of Greenville, in the County of Greenville,  
State of South Carolina, being known and designated as Lot No. 110 and a portion of  
Lot No. 109 on plat of Woodfields, recorded in the R.M.C. Office for Greenville  
County, South Carolina, in Plat Book "W", page 49, and having, according to said  
plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Crestfield Road, joint front  
corner Lots 110 and 111, and running thence along Crestfield Road, S. 51-37 W. 90  
Feet to an iron pin, joint front corner Lots 109 and 110; thence N. 41-17 W. 138.6  
Feet to an iron pin in the rear line of Lot No. 109; thence N. 51-37 E. 87 feet to  
a point; thence N. 59-24 E. 10 feet to an iron pin, joint rear corner Lots 110 and  
111; thence S. 38-23 E. 137 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

assigns forever.
