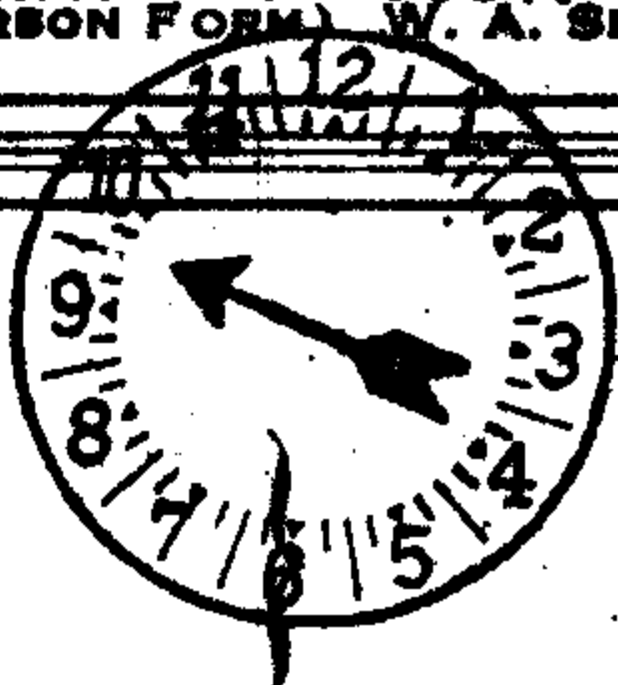

We, Gordon E. and Alice Jane B. Davenport - - - - - SEND GREETING:

Whereas we, the said Gordon E. and Alice Jane B. Davenport
in and by our certain promissory note in writing, of even date with these
Presents, are well and truly indebted to The Pelzer-Williamston Bank
in the full and just sum of Nineteen Hundred Twenty-two and 55/100 - - (\$1,922.55) - - -
- - - Dollars - -, to be paid on demand after date

, with interest thereon from date
at the rate of 6 per centum per annum, to be computed and paid semi-annually
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its
maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity
it should be deemed by the holder thereof necessary for the protection of his interests to place and
the holder should place the said note or this mortgage in the hands of an attorney for any legal
proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses
including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness,
and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Oakland Township, Greenville County,
State of South Carolina, lying on the North side of South Carolina Highway No. 8,
containing 3.31 acres, more or less, being bounded on the North by lands of Allen
and King, on the East by other lands of Harold J. and Mary M. Baynard, on the South
by South Carolina Highway No. 8 and on the West by lands of James Allen, being
more fully described as follows according to plat of J. Coke Smith and Son, Sur-
veyors, dated August 6, 1955:

BEGINNING at a nail in the center of South Carolina Highway No. 8 at the Northwest
corner of other lands of H. J. and Mary M. Baynard, thence North 82-30 West 349.1
