WHEREAS, I, the said Dorothy Hipp Gunter, am indebted unto PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, Chattanooga, Tennessee, by my promissory note, in writing, of even date herewith, of which the following is a copy:

"For value received, we, Borothy Hipp Gunter and C. Guy Gunter, jointly and severally promise to pay to the order of PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY the principal sum of Fifty Thousand and no/100 (\$50,000.00) Dollars, to be paid Six Hundred Twenty-Five and no/100 (\$625.00) Dollars as to principal on the first day of September, 1960, and a like amount as to principal on the first day of each succeeding December, March, June and September thereafter, up to and including the first day of March, 1980, with any remaining balance due and payable on the first day of June, 1980, with interest thereon until paid at six (6%) per cent per annum from date on the whole amount of said principal sum remaining unpaid from time to time, which interest shall be payable quarter-annually on the same date as the principal payments above; all installments of principal and interest of this note being payable in lawful money of the United States of America at the Home Office of PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY in Chattanooga, Tennessee, or at such other place as the holder hereof may from time to time designate in writing.
