

(2) All that certain tract or parcel of land situate, lying and being in Paw Creek Township, Mecklenburg County, North Carolina, more particularly described as follows:

BEARINGS at an iron in the northeasterly corner of Tract A as described in deed dated April 2, 1956 from Malcolm B. Blankenship et ux., recorded in Deed Book 1836, Page 139, Public Records of said Mecklenburg County; thence south 4 degrees 06 minutes 30 seconds east along the easterly line of said Tract A for a distance of 259.54 feet to an iron; thence south 68 degrees 37 minutes 15 seconds west for a distance of 477.08 feet to an iron; thence north 17 degrees 53 minutes 20 seconds west for a distance of 231.12 feet to an iron and a corner of said Tract A; thence north 66 degrees 48 minutes 10 seconds east along the northerly line of said Tract A for a distance of 540.34 feet to the point of beginning; said parcel of land containing 2.785 acres, as shown on print of survey dated June 20, 1958 prepared by H. P. Davis, Registered Surveyor.

(3) All that certain lot of land, situate, lying and being in Long Creek Township, Mecklenburg County, State of North Carolina, and more particularly described as follows:

BEARINGS at an iron pin in the southerly edge of Sunset Drive, said iron being the southwest corner of the tract of land conveyed to Grace D. Sailors by deed recorded in Book 964, Page 186, of the Mecklenburg County Registry; and runs thence with the dividing line between the property of Grace D. Sailors and John P. Todd N 3-08-50 E 349.77 Feet to an iron stake, and thence S 59-45-00 E 50 ft. to an iron stake; thence S 3-08-50 W 349.77 ft. to an iron stake in the southerly edge of Sunset Drive; thence N 59-45-00 W 50 Ft. to an iron stake, the point of BEARINGS.

(4) All that certain lot or parcel of land, situate, lying and being in Huntersville Township, Mecklenburg County, State of North Carolina, and more particularly described and defined as follows:

BEARINGS at an iron in the northerly margin of Gilead Road, which iron is located N 69-33 E 200.0 feet from the intersection of the northerly margin of Gilead Road with U. S. Highway #21; and runs thence N 20-27 W 20.0 feet to an iron; thence N 69-33

E 20 feet to an iron; thence S 20-27 E 20 feet to an iron in the northerly margin of Gilead Road; thence with said margin of Gilead Road S 69-33 W 20 feet to the point of BEARINGS; all as shown by survey of R. B. Pharr dated August 17, 1959.

(5) All that certain lot or parcel of land, situate, lying and being in Lemley Township, Mecklenburg County, State of North Carolina, and more particularly described and defined as follows:

BEARINGS at an iron in the northerly margin of Gilead Road, said iron being N 12-30 W 39.35 feet from a point in the centerline of Gilead Road which is S 62-10-30 E 140.0 feet from the intersection of the centerline of Gilead Road with the centerline of Bud Henderson Road; and runs thence from said iron in the northerly margin of Gilead Road N 12-30 W 20 feet to an iron; thence S 62-10-30 E 20 feet to an iron; thence S 12-30 E 20 feet to an iron in the northerly margin of Gilead Road; thence with the northerly margin of Gilead Road N 62-10-30 W 20 feet to the BEARINGS; all as shown by survey of R. B. Pharr dated August 17, 1959.

(6) All that certain premises in Asheboro Township, Randolph County, North Carolina, described as follows:

BEARINGS at an iron stake in the Southern right of way line of Hampton Street and on the North side of an alley, said beginning stake being North 88 degrees 28 minutes West and a distance of 305.75 feet from the intersection of the Western right of way line of North Fayetteville Street and the Southern right of way line of Hampton Street; running thence South 5 degrees 29 minutes West 168.42 feet to a stake; thence North 78 degrees 10 minutes West 110.59 feet to a stake, the South-East corner of Lot No. 12; thence North 9 degrees 10 minutes East 153.69 feet to a stake in the Southern right of way line of Hampton Street, the North-East corner of Lot No. 12; thence in an Easterly direction along said right of way line 100 feet to the point and place of the beginning, the same being Lots Nos. 8, 9, 10 and 11 of the Property of Stowe's Greenhouses, Inc., Plat of which is found of record in the Office of the Register of Deeds for Randolph County, North Carolina, in Plat Book 9 at Page 38.

(7) All that certain piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on
