NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All ~~the~~ <sup>those</sup> pieces parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Lee Road, Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 48, 47, 46, 45 and a portion of Lot No. 44 of Block E, as shown on a plat of Buena Vista, dated April 4, 1949, revised April 26, 1949, prepared by W.N. Willis, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book W at pages 11 and 29, and having, in the aggregate, according to said plat the following metes and bounds:

BEGINNING at an iron pin at the Northeastern corner of the intersection of Lee Road and Elberta Street, and running thence with the Northern side of Lee Road N. 73-08 E. 151 feet to an iron pin in the front line of Lot No. 44; thence along a new line through Lot No. 44 N. 16-52 W. 150 feet to an iron pin in the rear line of Lot No. 44 at the joint rear corner of Lots Nos. 28 and 40; thence with the line of Lot No. 40 S. 73-08 W. 151 feet to an iron pin on the Eastern side of Elberta Street; thence with the Eastern side of Elberta Street S. 16-52 E. 150 feet to the point of beginning.
