Irene S. Edwards (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----One Thousand and no/100-----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Western side of Houston Street, being known and designated as Lot 9, Block G, Chapin Spring Land Company plat, recorded in Plat Book E at page 41, and according to said plat having the following metes and bounds:

BEGINNING at an iron pin on the Western side of Houston Street, corner of Lot 8, and running thence with the line of Lot 8, S. 88 W. 133.4 feet to an iron pin; thence with the line of Lot 7, in a Southerly direction 60 feet to an iron pin; thence with the line of Lot 10, N. 88 E. 192.2 feet to an iron pin on said Street; thence with said Street, N. 2 E. 60.1 feet to the beginning.

Being the same property conveyed to the Mortgagor by deed recorded in Deed Book 644 at page 252.
