ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of Seminole Drive, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 60 on Plat No. 2 of Sunset Hills made by R. E. Dalton, Engineer, December 1945, recorded in the RMC Office for Greenville County, S. C. in Plat Book "P", pages 18 and 19, said lot fronting 75 feet along the Southwest side of Seminole Drive, running back to a depth of 175 feet on the Southeast side, to a depth of 175 feet on the Northwest side, and being 75 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
