WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100 --

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Sans Souci, and being shown as Lots Nos. 15 and 16 on Plat of Elizabwth Heights recorded in Plat Book F, at page 298, R.M.C. Office for Greenville County, and being more particularly described as follows:

BEGINNING at a stake at the Northeast corner of McCrary Street and Edwards Street, and running thence with Edwards Street, N. 9 1/2 E. 150.1 feet to a stake; thence with the line of Lot No. 30, S. 76-15 E. 112.1 feet to a stake; thence with the line of Lot No. 17, S. 13 1/2 W. 150 feet to McCrary Street; thence with said Street, N. 76-15 W. 100 feet to the beginning.
