NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by said note, and for better securing the payment thereof to second party, according to the terms of said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand paid by second party, receipt whereof is hereby acknowledged, has granted, bargained, sold and released, in fee simple, and by these presents does grant, bargain, sell and release, in fee simple, unto second party, its successors and assigns, the following described lands, including but not limited to, all trees, timber, shrubbery, fixtures and improvements now and hereafter thereon:

contained in the said note, evidencing a loan made by second party, will more fully appear by reference thereto.

All that piece, parcel and tract of land lying and being in Greenville County, South Carolina, on a county road, between the Washington Church Road and a road from Williamston to the Ware Place and referred to in some of the records as being in Oaklawn Township and in other records as being in Grove Township. It contains Ninety (90) acres, more or less, and is the major portion of the lands acquired by J. T. Arnold, Mrs. Alice W. Arnold and Mrs. S. C. Bradley by deed from City Loans, Inc., of Winston-Salem, North Carolina, dated December 15, 1953, recorded in Deed Book 579, page 265, R. M. C. Office, Greenville County, South Carolina. A share of the interest of Alice W. Arnold in the said lands was acquired by J. T. Arnold through inheritance. Another portion was acquired by Mrs. S. C. Bradley by inheritance from Alice W. Arnold, thus vesting title to the entire tract of land acquired from City Loans, Inc., in J. T. Arnold and Mrs. S. C. Bradley, with Mrs. S. C. Bradley conveying all her right, title and interest in 19.8 of the original plot to Mrs. S. C. Bradley by deed dated February 4, 1957, recorded in Deed Book 579, page 248, R. M. C. Office, Greenville County with the said Mrs. S. C. Bradley on the same day and date conveying all of her right, title and interest in 90 acres of the said lands unto J. T. Arnold. The parcel of land now owned by J. T. Arnold is bounded by lands now or formerly of Washington Church lot, H. H. Newton and Carl Allen on the North; a public road on the Southeast; Mrs. S. C. Bradley on the Southwest; H. C. Madden on the Northwest, with the said lands being more specifically described on plat of W. L. Mitchell dated August 18, 1932, recorded in Plat Book 00, page 22, R. M. C. Office, Greenville County, together with a plat of C. O. Riddle, Reg. Land Surveyor, dated December 5, 1956, recorded in Plat Book UU page 17, R. M. C. Office, Greenville County. The Mitchell plat describes the original purchase of 109.8 acres with the Riddle plat covering and describing the 19.8 acres conveyed off the properties described in the Mitchell plat with it being intended that the lands herein referred to as belonging to J. T. Arnold shall and does cover and include all of the properties covered by the Mitchell plat except such properties as are covered by the Riddle plat.
