

BEGINNING at a point in the south line of Doe Avenue, a distance of one hundred fifteen (115) feet northwest of an iron pin in the sidewalk and being a corner to the property of W. R. Allen heirs; thence at right angles to Doe Avenue south fourteen (14°) degrees west a distance of one hundred seventy-five and two-tenths (175.2) feet to a hub on the north line of an alley; thence with the line of said alley north seventy-six (76°) degrees west one hundred sixty-three (163) feet to a point in the east line of the Elizabethton School property; thence with the line of said school property north fourteen (14°) degrees east a distance of one hundred seventy-five and two-tenths (175.2) feet to a point in the south line of Doe Avenue; thence with the line of Doe Avenue south seventy-six (76°) degrees east a distance of one hundred sixty-three (163) feet to the beginning.
