ALL that lot of land with the buildings and improvements thereon, situate on the North side of Oregon Street, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No.2, Block J, on plat of property of W.W. Carter & Associates (being a revision of Block J of Kanatenah Subdivision) made by Dalton & Neves, Engineers, April 1941, recorded in the RMC Office for Greenville County, S.C. in Plat Book K, Page 86, said lot fronting 68 feet along the North side of Oregon Street and running back to a depth of 165 feet on the East side, to a depth of 165 feet on the West side and being 68 feet across the rear.
