Greenville , State of South Carolina: on the northwest corner of South Washington Avenue and Texas Avenue, near the City of Greenville, being a portion of Lots 8 and 9, Block P, as shown on a plat of Highlands, recorded in Plat Book K at Pages 50 and 51, RMC Office for Greenville County, and according to a recent survey made by J. C. Hill is described as follows:
