(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Eleven Thousand and No/100** -----

DOLLARS (\$ 11,000.00), with interest thereon from date at the rate of **six and one-half (6½%)** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, and known and designated as Pinehurst, Section 2, property of W. J. Burty, according to a plat prepared by J. Mac Richardson, April, 1960, and according to said plat, Lot 27 having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 27 and 28, and running thence along the line of Lot 28 N. 71-26 E. 175 feet to an iron pin; running thence N. 18-34 W. 90 feet to an iron pin at the joint rear corner of Lots 27 and 26; running thence along the line of Lot 26 S. 71-26 W. 175 feet to an iron pin on the eastern side of Vista Drive; running thence along the eastern side of Vista Drive S. 18-34 E. 90 feet to an iron pin, point of beginning.

Being the same premises conveyed to the mortgagor by deed of W. E. Shaw, Trustee for W. E. Shaw and W. N. Leslie, to be recorded.
