All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the southwest side of Lynhurst Drive, near the City of Greenville, being shown as lot # 187, on a plat of Oak Crest, recorded in Plat Book GG at Page 130, and 131, and described as follows:
