"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate on the northeast side of Pleasantdale Circle, being shown as lot # 29 on a plat of Pleasantdale, recorded in Plat Book QQ at Page 19, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Pleasantdale Circle, joint front corner of lots # 28 and 29, and running thence with the line of lot # 28, N. 43-23 E. 175 feet to pin; thence S. 46-37 E. 100 feet to pin, rear corner of lot # 27; thence with the line of lot # 27, S. 43-23 W. 175 feet to pin on Pleasantdale Circle; thence with the northeast side of said Circle, N. 46-37 W. 100 feet to the point of beginning.
