"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, in the City of Greenville, on the East side of East Faris Road, being known and designated as Lot No. 98 as shown on Plat of Forest Heights recorded in Plat Book P, at page 71, and being more particularly described, according to said Plat, as follows:

BEGINNING at an iron pin on the East side of East Faris Road, at joint front corner of Lots Nos. 97 and 98, and running thence with the joint line of said lots, N. 77-53 E. 225 feet to a point in the center of a branch; thence up the meanders of said branch, the chord of which is N. 25-30 W. 201.6 feet to a point in the center of said branch, joint rear corner of Lots Nos. 98 and 99; thence with the joint line of said lots, S. 58-09 W. 235 feet to an iron pin in the East side of East Faris Road; thence with said Road, S. 31-00 E. 100 feet to an iron pin; thence still with said Road, S. 18-54 E. 25 feet to the point of beginning.
